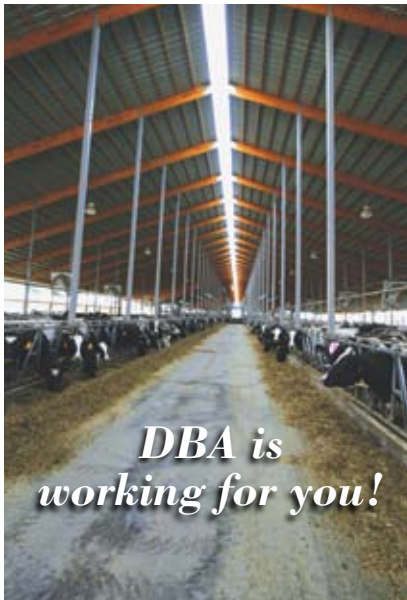
DBA represents Wisconsin's dairy producers and dairy-related businesses and has made significant strides for this \$26.5 billion-per-year industry.
